

ALL STAR PREP PACKET

WHAT IS ALL STAR PREP

The Renegade All Stars prep program serves as an introduction to all star cheer. The prep program is fit for athletes just being exposed to the sport and has less commitment than our elite program. Overall, the prep program has a shortened season, limited weekly practice and travel, and less financial commitment. Athletes participating in the prep program must be 5 years old by August 31, 2021.

ALL STAR PREP GOMANTARIN

Practices: Tuesdays for 1.5 Hours

Tumbling: Highly Recommended

1HR Tumbling (Thursdays) \$25/month

If an athletes misses more than 3 practice in a season, then they will be removed from choreography and no refund will be given.

GOMPETITIONS

Renegade All Stars prep program will attend 3 MANDATORY competitions. Prep athletes will travel no further than Utah.

HNANGAL OBLIGATION

Each athlete will be required to fulfill this financial agreement for September 2021-April 2022. The contract will remain valid unless the athlete (1) moves more than 1 hour from the area, or (2) has proper documentation from a medical professional stating they are no longer physically capable to perform their duties for the remainder of the season. There will be no refund for any monthly tuition already paid or items pre-ordered. If there remains a balance on the account, the athlete must pay in full to receive any items already ordered or it will become property of Renegade All Stars.

Any account that becomes 30 days past due will need to have arrangements made or will be turned over to collections. Tuition is per season, thus joining after May will not prorate your tuition payments.
